RS.1 The Industrial Training Act and the Industrial Training Boards; history, machinery, progress and criticisms.

Includes the reasons leading up to the Act, the machinery of the Act, progress in achieving the objectives of the Act, criticisms of the principle of the Act, and a critique of these criticisms.

RS.2 A comparison of attitudes of engineering firms to the importance of the Industrial Training Act, 1964, for the country and for their own firm.

Analysis of the attitudes of engineering firms to the importance of the Act both to the country and their own firm. Based on the replies from a questionnaire sent to 600 engineering firms in the London area. The responses were classified and analysed with respect to the following parameters: size of firm concerned, whether or not firm claimed a grant in the first and/or second grant year, grant received first and second years, change in grant from one year to next, and whether or not the firm was a member of a group training scheme.

RS.3 Attitudes of engineering firms towards the E.I.T.B.'s previous levy-grant schemes.

Deals with the attitudes of engineering firms towards the first differential levy of the Engineering I.T.B. and towards the question of whether or not the Board's levy-grant system was losing its effectiveness.

Attitudes of engineering firms towards the value of Off-the-Job education and training facilities to their own particular firm.

A critical review of many of the research findings concerning the predominant determinants of labour turnover brought together within a theoretical framework.
